Prospective bidders are hereby notified of the clarifications to the Request for Expression of Interest published on 01 March 2019 for the Eligibility and Shortlisting of Financial and Technical Advisor for Mining Assets.

A. ELIGIBILITY DATA SHEET

2.1(a)(i) Pursuant to Government Procurement Policy Board (GPPB) Circular No. 07-2017 "Deferment of the Implementation of the Mandatory Submission of PhilGEPS Certificate of Registration and Membership", bidders shall submit the following:

1. Class "A" Eligibility Documents required to be uploaded and maintained current and updated in the PhilGEPS pursuant to Section 8.5.2 of the 2016 Revised IRR of RA9184:
 - a. SEC or DTI Registration Certificate;
 - b. Mayor's/ Business Permit or its equivalent document;
 - c. Tax Clearance Certificate; and
 - d. Audited Financial Statements.

The AFS shall be, showing, among others, the prospective bidder's total current assets and liabilities, stamped and "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission in accordance with Section 23.1(a) (vii) of the 2016 Revised IRR of RA 9184.

In case the bidder opted to submit their Class 'A' Documents, the Certificate of PhilGEPS Registration (Platinum Membership) shall remain as post-qualification requirement to be submitted in accordance with Section 34.2 of the 2016 Revised IRR of RA 9184.

2. Valid PhilGEPS Certificate of Registration under Platinum category with updated Annex "A", in lieu of Class "A" documents.

3. A combination of the PhilGEPS Certificate of Registration under Platinum Category with Annex "A" and the above Class "A" documents.
