**INVITATION TO BID**  
**Security Services**

for CY 2018  
(PMO 02A-2018)

1. The **Privatization and Management Office-Bids and Awards Committee**, through its Retention Fund, intends to apply the sum of **Twenty Three Million Five Hundred Seventy Three Thousand Five Hundred Seventy One Pesos and 24/100 (P23,573,571.24)**, being the **Approved Budget for the Contract (ABC)**, to payments under the contract for **Security Services for NCR / LUZON CY 2018 (PMO 02A-2018)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **PMO-BAC** now invites bids from Philippine Government Electronic Procurement System (PhilGEPS)-registered security agencies for the following supply of **Security Services for CY 2018** for one (1) year.

Bidders should be in compliance with all of its ongoing government and private contracts, and should have completed in the Philippines, **within the last two (2) years** from the date of submission and receipt of bids, **at least one (1) single contract or accumulated purchase orders or contracts** of a similar nature as the contract to be bid, amounting to **at least fifty percent (50%) of the ABC**, to the satisfaction of the end-user/s. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II - Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the PMO-BAC Secretariat at the 6<sup>th</sup> Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City, from 8:00 A.M. to 5:00 P.M., Mondays to Fridays, starting **3 January 2018**, or at Telephone No. 893-1886.
5. Bidding Documents may be acquired by interested Bidders on **3 January 2018 from 8:00 A.M. to 5:00 P.M.**, at the PMO-BAC Secretariat, 6<sup>th</sup> Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City, upon payment of the following non-refundable fee of **Twenty Five Thousand Pesos (P25,000.00)** to the PMO Cashier located at the 6<sup>th</sup> Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City.

Bidding Documents may also be downloaded from the PhilGEPS and PMO websites, provided that bidders shall pay the non-refundable fee of **Twenty Five Thousand Pesos (P25,000.00)** for the Bidding Documents downloaded not later than the Submission and Opening of Bids.

6. PMO-BAC will hold a **Pre-Bid Conference on 10 January 2018, Wednesday, at 2:00 P.M.**, at the 4<sup>th</sup> Floor Activity Area, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City, which shall be open only to parties who have purchased the Bidding Documents.
7. Bids must be delivered to the following address on or before the schedule of bid opening:

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Clause 18 of the Instructions to Bidders.


Bid submission and opening shall be on **23 January 2018, Tuesday, at 10:00 A.M.** to be held at the 4<sup>th</sup> Floor, Activity Area, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City.

Bids will be opened on the date and time and at the place cited above in the presence of the bidders or their duly authorized representatives. Late bids shall not be accepted.

8. PMO-BAC shall not compensate or indemnify bidders or any other person for any expenses incurred in the preparation of bids.
9. PMO-BAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
