SUPPLEMENTAL/BID BULLETIN No.1

**For the Procurement Through Public Bidding of Security Services for National Capital  
Region (NCR) and Luzon  
(PMO 02A-2018)**

**A. Notice to Prospective Bidders**

1. Prospective bidders are hereby notified of the clarification to the Bidding Documents for the procurement of the Privatization and Management Office's (PMO) Security Services for National Capital Region (NCR) and Luzon (PMO 02A-2018).
2. The Supplemental/Bid Bulletin No. 1 dated 16 January 2018 will be made available to all prospective bidders who have secured Bidding Documents and have paid the non-refundable fee for the bidding documents. This Supplemental/Bid Bulletin No.1 will also be posted in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites.
3. It is conclusively presumed that in the preparation and submission of its Bid, the Bidder has taken into account the information and procedures set forth in the Bidding Documents and this Supplemental/Bid Bulletin No. 1.

**B. Clarification to the Bidding Documents**

All concerned participating/prospective bidders are hereby informed of the correction on the following:

1. Section II - Instruction to Bidders, Clause 12.1 (a) (iv) Documents Comprising the Bid: Eligibility and Technical Components, - Statement of all its ongoing and completed government and private contracts within the period stated in the **BDS**, including contracts awarded but not yet started

Please see attached annexes for the prescribed format of the following:

- a. Annex "A" - Statement of Ongoing Government and Private Contracts Including Contracts Awarded But Not Yet Started
- b. Annex "B" - Statement of Completed Government and Private Contracts (same format will be used for the SLCC)

2. Section III – Bid Data Sheet, Clause 12.1 (a) (i) - Eligibility Documents

Valid and current Certificate of Registration as Contractor issued to the Bidder by the Regional Office of the Department of Labor and Employment (DOLE) where it principally operates, **pursuant to Department Order No. 174, Series of 2017**. However, if the current Certificate of Registration is still valid under Department Order No. 18-A, Series of 2011 or Department Order No. 150-16, Series of 2016, the PMO-BAC will accept the submission of the said document.

3. Section VIII – Bidding Forms, Annex D1 to D6

The bidder shall use the amount of PhilHealth Contribution indicated in Annex D1 to D6 of the Bidding Documents. The increase in premium contributions of the security guards shall be adjusted upon implementation of the contract.

4. Bids shall be submitted using the two-envelope system wherein all copies of eligibility and technical components (Original, Copy 1 and Copy 2) shall be put in one envelope and all copies of financial component (Original, Copy 1 and Copy 2) in another envelope. There is no need to put the two envelopes in a bigger envelope. Genuine documents are not required to be presented during the Submission and Opening of Bids on January 23, 2018, but these are required to be presented during the Post-Qualification.
5. A duly notarized Secretary's Certificate, attesting the authority of the signatory as the duly authorized and designated representative of the corporation, partnership or joint venture must be attached to the Omnibus Sworn Statement. The Secretary's Certificate must be specific to the bidding of Security Services for NCR and Luzon (PMO 02A-2018) of Privatization and Management Office.
6. Authorization or Special Power of Authority (SPA) must be submitted by the bidder's representative in case the authorized signatory is not present during the submission and opening of bids.

**C. Miscellaneous**

1. The provisions of the Bidding Documents shall continue to bind the Bidders and shall remain effective unless inconsistent with the provisions of this Supplemental/Bid Bulletin No. 1.
2. The validity, legality or enforceability of the remaining provisions of each and all of the Bidding Documents and this Supplemental Bid Bulletin No. 1 will not be affected in case any one or more of the provisions are held to be invalid, illegal or unenforceable.
