Invitation to Bid, Clause 6: PMO-BAC will hold a Pre-Bid Conference on 7 December 2018, Friday, at 2:00 P.M, at the 4th Floor, Activity Area, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City., ~~which shall be open only to parties who have purchased the Bidding Documents.~~
2. Section II. Instructions to Bidders, Clause 20. Sealing and Marking of Bids
 - a. All prospective bidders shall submit six (6) envelopes enclosed in one (1) single sealed envelope or box, marked as follows;

- b. The original Eligibility and Technical documents, and the original Financial documents should be duly authenticated.
3. Section III. Bid Data Sheet, ITB Clause 5.4: The Bidder should have completed in the Philippines, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract ~~or accumulated purchase orders or contracts~~ that is similar to the contract to be bid, equivalent to at least fifty percent (50%) of the ABC.

For this purpose, similar contracts shall refer to contracts which are of similar nature and complexity to the contract to be bid.

4. Section III. Bid Data Sheet, ITB Clause 12.1(a)(i): The Bidder shall also submit the following:
 - a. For any participating partnership/corporation, include Articles of Partnership (for partnership) and Articles of Incorporation and By-Laws (for corporation) including any amendments thereto, and its latest General Information Sheet (GIS) filed with the Securities and Exchange Commission (SEC) which should not be earlier than 2017 or 2018, ~~if available~~. If the Bidder is a partnership, its latest Articles of Partnership and a notarized Certification, issued by its Managing Partner, stating that it is not required to file a GIS with the SEC and providing the equivalent information required in the GIS.
 - b. Valid and current License to Operate issued to the Bidder by the Philippine National Police - Supervisory Office for Security and Investigation Agency (PNP-SOSIA) pursuant to Republic Act No. 5487 and its Implementing Rules and Regulations.
 - c. Valid and current Certificate of Registration as Contractor issued to the Bidder by the Regional Office of the Department of Labor and Employment (DOLE) where it principally operates, pursuant to Department Order No. 174, Series of 2017.
 - d. Tax clearance issued by the Bureau of Internal Revenue (BIR).**
