

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID
Pest Control Maintenance PMO 04-2009

The Privatization and Management Office through its Bids and Awards Committee (PMO-BAC), intends to apply the amount of **ONE HUNDRED THIRTY TWO THOUSAND THREE HUNDRED PESOS (P132,300.00)** from the General Appropriations Act being the Approved Budget for the Contract (ABC) for Pest Control Maintenance. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

The PMO-BAC now invites G-EPS registered companies/contractors to apply for eligibility and to bid for Pest Control Maintenance for contract duration of one (1) year.

Bid documents will be available starting 3 April 2009, Friday from 9:00 a.m. to 4:00 p.m. at the 4th Floor PMO-BAC Secretariat upon payment of a non-refundable fee of **Two Thousand Pesos (P 2,000.00)** in cash to the PMO Cashier located at the 6th Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City.

The PMO-BAC will conduct its **Pre-Bid Conference** open to all interested bidders on **13 April 2009, Monday at 10:00 a.m.**, 6th floor Privatization and Management Office, 104 Gamboa St., Legaspi Village, Makati City.

Advanced Eligibility Check shall be on **27 April 2009, Monday at 10:00 a.m.** at the 6th Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village, Makati City.

Bid Opening shall be on 29 April 2009, Wednesday at 10:00 a.m. at the 6th Floor, Privatization and Management Office, 104 Gamboa Street, Legaspi Village Makati City. Bids will be opened in the presence of the bidders or their representatives who choose to attend. Late bids shall not be accepted. All Bids must be accompanied by a Bid Security in any of the following forms:

Form of Security	Minimum Amount in % of ABC
1. Cash, cashier's check or manager's check; <i>OR</i>	One percent (1%)
2. Bank Guarantee	One & a half percent (1 ½%)

The PMO-BAC shall not compensate or indemnify bidders for any expenses incurred in the preparation of the bid.

Moreover, the **PMO-BAC reserves the right to reject any or all bid proposals, waive any formality in the bid requirements, declare the bidding a failure without thereby incurring any liability to the affected Bidder or Bidders, or award the contract to the bidder whose offer is the Lowest Calculated and Responsive Bid** and most advantageous to the Government.
