- 3. Medical Certificates of security personnel to be assigned to PMO properties issued within the last thirty (30) days;
- 4. Results of psychological evaluation tests, neuro-psychiatric examinations, and drug tests of security personnel to be assigned to PMO properties issued within the last thirty (30) days;



- 5. Certificates/proof of training of security personnel to be assigned to PMO properties;
- -6. Deed of Undertaking to enter into an agreement with the security personnel for the establishment of a retirement plan pursuant to Department Order No. 150-16; and
- *7.* Duly signed Contractors Agreement.

Failure to comply with the above requirements shall be grounds for forfeiture of bid security and imposition of appropriate sanctions as provided in the 2016 revised IRR of R.A. 9184.
