RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Administrative Division a request for the procurement of Power House Pest Control Services through Negotiated Procurement -Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (Php100,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-03 from January 25-30, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act"). In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1) Power House Pest Control Services;
- 2) RJ Angel Pest Control.;
- Pinagpala Pest Control; and,
- Mac J Pest Control Services

WHEREAS, on January 30, 2023, the Admin authorized canvasser, received only two (2) quotation, namely:

- 1) Power House Pest Control Php87,776.40; and,
- 2) RJ Angel Pest Control Services Php85,000.00

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 1) Power House Pest Control Services Compliant and responsive to all requirements; and,
- 2) RJ Angel Pest Control Services Non-compliant to the minimum requirements

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby RESOLVE as it is RESOLVED, to:

- a) declare the price quotation of Power House Pest Control Services as the Lowest Calculated and Responsive Bid (LCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Pest Control Maintenance Services to PMO for CY 2023 Solicitation No. PMO-23-03 to Power House Pest Control at a contract price of Eighty Seven Thousand Seven Hundred Seventy-Six and 40/100 (Php87,776.40).
