1) Newark Spring Water Corp. - Php77,760.00

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

1) Newark Spring Water Corp. - Compliant and responsive to all requirements

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) declare the price quotation of Newark Spring Water Corp. as the Single Calculated and Responsive Bid (LCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Supply of Purified Drinking Water for PMO for CY 2023 Solicitation No. PMO-23-07 to Newark Spring Water Corp. at a contract price of Seventy-Seven Thousand Seven Hundred Sixty Pesos (Php77,760.00).
