## RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

**WHEREAS,** the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of Various Repairs and Maintenance Supplies (Electrical, Plumbing, And Hardware Materials/Equipment) – Mile Long Complex (MLC) through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Five Thousand Nine Hundred Eighty-One Pesos (Php105, 981.00);

**WHEREAS,** the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-09 from February 15-21, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act"). In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1.) Remitechs Electrical Services;
- 2.) Luzon Sales Co., Inc.;
- 3.) Champion Hardware & Co., Inc.; and
- 4.) Innovalite Inc.

**WHEREAS,** on 21 February 2023, the Marketing Division I authorized canvasser, received four (4) quotation? namely:

- 1.) Remitechs Electrical Services;
- 2.) Luzon Sales Co., Inc.;
- 3.) Champion Hardware & Co., Inc.; and
- 4.) Boston Builder's Center

**WHEREAS,** the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 1.) Remitechs Electrical Services Non-compliant to the minimum requirements;
- 2.) Luzon Sales Co., Inc. Non-compliant to the minimum requirements;
- 3.) Champion Hardware & Co., Inc. Compliant and responsive to all requirements; and
- 4.) Boston Builder's Center Non-compliant to the minimum requirements

**NOW THEREFORE, WE**, the Members of the PMO-BAC, hereby  $\bf RESOLVE$  as it is  $\bf RESOLVED$ , to:

- a) declare the price quotation of Champion Hardware & Co., Inc. as the Lowest Calculated and Responsive Bid (LCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Various Repairs and Maintenance Supplies (Electrical, Plumbing, And Hardware Materials/Equipment) Mile Long Complex (MLC) with Solicitation No. PMO-23-09 to Champion Hardware & Co., Inc. at a contract price of Ninety-Seven Thousand Three Hundred Sixty Three Pesos (Php97,363.00).
