RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC received from the Administrative Division a request for the procurement of Various Janitorial Supplies through Shopping (Section 52.1(b)) with an Approved Budget for the Contract (ABC) of Eighty-Nine Thousand Three Hundred Pesos (Php89,300.00);
