Resolution No. 68-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Custodianship Services Division (CSD) a request for the procurement of Eleven (11) unit Smart Phone through Negotiated Procurement - Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Two Hundred Eighteen Thousand Pesos (Php218,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-31 from 5 – 14 April 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act"). In addition, the below suppliers were also invited to submit their quotations, namely:

- 1) Electroworld;
- 2) Octagon;
- 3) Joyce Malimban;
- 4) SV Glorietta; and,
- 5) Silicon Valley.

WHEREAS, on 14 April 2023, the End-User received four (4) quotations from suppliers, namely:

- 1) Silicon Valley Computer Group Phils., Inc. - PhP207,489.00
- 2) Imax Technologies, Inc. - PhP241,482.00
- 3) Luxenberg Marketing, Inc. - PhP152,989.00
- 4) CCP Computer Technologies Inc. - PhP192,489.00

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 1) Silicon Valley Computer Group Phils., Inc. - Compliant and responsive to all the minimum requirements.
- 2) Imax Technologies, Inc. - Non-Compliant and unresponsive to the minimum requirements.
- 3) Luxenberg Marketing, Inc. - Non-Compliant and unresponsive to the minimum requirements.
- 4) CCP Computer Technologies Inc. - Non-Compliant and unresponsive to the minimum requirements.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of **Silicon Valley Computer Group Phils., Inc.** as the Lowest Calculated and Responsive Bid (LCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity (HoPE), Atty. Maan Vanessa L. Doctor, to award the*

procurement of the Eleven (11) units of Smart Phone with Solicitation No. PMO-23-31 to **Silicon Valley Computer Group Phils., Inc.** with a total amount of **Two Hundred Seven Thousand Four Hundred Eighty-Nine Pesos (PhP207,489.00).**
