

**Privatization and Management Office

Resolution No. 75-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division a Request for Procurement of Backup and Recovery Software through Negotiated Procurement – Small Value Procurement (Sec. 53.9) with an Approved Budget for the Contract (ABC) of Three Hundred Sixty Thousand Pesos (Php360,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-39 from 11 to 16 May 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”).

WHEREAS, on 11 May 2023, three (3) Prospective Bidders were invited to submit quotation and documentary requirements for Request for Quotation (RFQ) with Solicitation No. PMO-23-39 until 16 May 2023, namely:

- 1) Commsource Systems and Integrated Solutions, Inc.;
- 2) SoftwareOne Philippines Corp.; and
- 3) Wordtext Systems, Inc.

WHEREAS, after the deadline for submission and receipt of quotations on 16 May 2023, the PMO-BAC received only one (1) quotation from Commsource Systems and Integrated Solutions, Inc. in the amount of Three Hundred Forty-Eight Thousand Five Hundred Pesos (PhP348,500.00).

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), evaluated the documentary requirements submitted by Commsource Systems and Integrated Solutions, Inc. and found that it is compliant and responsive to all the minimum requirements of the End-User.

WHEREAS, after evaluation, the PMO-BAC and its Technical Working Group (TWG) found that the procurement project identified above is in accordance with the conditions and thresholds prescribed in Annex “H” of the IRR providing for the Consolidated Guidelines for the Alternative Methods of Procurement.

NOW, THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED** to:

- a) *declare the price quotation of Commsource Systems and Integrated Solutions, Inc. as the Single Calculated and Responsive Bid (SCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity (HoPE), Atty. Maan Vanessa L. Doctor, to award the procurement of Backup and Recovery Software with Solicitation No. PMO-23-39 to **Commsource Systems and Integrated Solutions, Inc.** with a total amount of **Three Hundred Forty-Eight Thousand Five Hundred Pesos (PhP348,500.00).***
