RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division (ITD) a request for the procurement of Internet Service Provider through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Seven Hundred Eighty Thousand Pesos (Php780,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-45 from 14-19 June 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act"). In addition, three (3) suppliers were also invited to submit their quotation, namely:

- 1) Eastern Telecommunication Phil., Inc.; \
- 2) Globe Telecom, Inc.; and,
- 3) PLDT, Inc.

WHEREAS, on 19 June 2023, the ITD's authorized canvasser, received only one (1) quotation from Eastern Telecommunication Phil., Inc. in the amount of Seven Hundred Seventy-Nine Thousand Nine Hundred Ninety Pesos and 40/100 (Php779,990.40);

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that Eastern Telecommunication Phil., Inc. is compliant and responsive to the minimum requirements;

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) declare the price quotation of Eastern Telecommunication Phil., Inc. as the Single Calculated and Responsive Bid (SCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Internet Service Provider with Solicitation No. PMO-23-45 to Eastern Telecommunication Phil., Inc. at a contract price of Seven Hundred Seventy-Nine Thousand Nine Hundred Ninety Pesos and 40/100 (Php779,990.40).
