RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Custodianship Services Division a Request for Procurement of the Pest Control Services at PMO Property in Toril, Davao City (1-year Contract) and Pest Control Services at PMO Warehouse in Valenzuela, City (1-year Contract) through Negotiated Procurement – Small Value Procurement (Sec. 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Seventy-Two Thousand Five Hundred Pesos (Php172,500.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-23-54 from August 31 to September 07, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act"). - 2) Power House Pest Control Services;
- 3) Pinagpala Pest Control Services;
- 4) Mapecon Philippines; and,
- 5) SUREOUT Pest Control Services.

WHEREAS, on 07 September 2023, the PMO-BAC, received proposals from four (4) bidders, namely ProEx Pest Control Services, Power House Pest Control Services, Pinagpala Pest Control Services, and Mapecon Philippines;

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), evaluated the submitted price quotations and found that:
