## Privatization and Management Office Bids and Awards Committee (PMO-BAC) Resolution No. 080-2024

## DECLARING FAILURE OF BIDDING

WHEREAS, the PMO-BAC, through its Secretariat, posted a Request for Expression of Interest (REI) for the procurement of Geodetic Services for the Conduct of Technical and Relocation Survey with Solicitation No. PMO-07-2024 from 13 May to 05 June 2024, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 21.2 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184 ("The Government Procurement Reform Act") with an Approved Budget for the Contract (ABC) of Two Million Pesos (PhP2,000,000.00);

**WHEREAS,** in response to the Request for Expression of Interest, two (2) prospective bidders submitted the Eligibility Documents before the deadline for submission, namely:

- H. O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates; and
- 2) Habbiling & Associates Land Surveying Services.

**WHEREAS,** on 14 May 2024 at 10:00 A.M., the PMO-BAC together with its Technical Working Group (TWG), opened the eligibility documents received and conducted a preliminary evaluation using non-discretionary "PASS/FAIL" criteria and the results are as follows:

**WHEREAS,** on 17 May 2024, the PMO-BAC received a Request for Reconsideration from Habbiling & Associates Land Surveying Services. The PMO-BAC denied the request for reconsideration of Habbiling & Associates Land Surveying Services through a letter dated 17 May 2024, for lack of merit.

**WHEREAS,** after careful evaluation conducted by the PMO-BAC and its TWG, H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates was declared and approved as the Shortlisted Consultant by the Head of the Procuring Entity (HoPE);

**WHEREAS,** on 05 June 2024, H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates submitted their technical and financial bids, the PMO-BAC through its TWG conducted a detailed evaluation of the bids received adopted the Quality-Cost Based Evaluation (QCBE) Procedure (60% for Technical Proposal and 40% for Financial Proposal), pursuant to Section 33.2.1 of the Revised IRR of RA 9184;

**WHEREAS,** H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates has a total score of 99.28%. The financial bid as evaluated is in the amount of One Million Nine Hundred Eighty Thousand Six Hundred Seventy-Eight Pesos and Ninety-Nine Centavos (PhP1,980,678.99) and is below the Approved Budget for the Contract (PhP2,000,000.00) by PhP19,321.01, and considered advantageous to the government;

**WHEREAS,** on 05 June 2024, the HoPE approved the recommendation of the PMO-BAC to declare H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates as the Single Rated Bid (SRB) for the procurement of Geodetic Services for the Conduct of Technical and Relocation Survey;

**WHEREAS**, on 07 June 2024, the PMO-BAC conducted the negotiations with H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates in accordance with Section 33.2.5 of the revised IRR of R.A. 9184;

WHEREAS, on 10 June 2024, H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates underwent Post Qualification pursuant to Section 34 of the RIRR. On 27 June 2024, post qualification report by the PMO BAC-TWG finds the bid of H.O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates to be noncompliant and non-responsive to the requirements and conditions specified in the Bidding Documents for the Project on the ground of its failure to comply with the prescribed Revised Omnibus Sworn Statement (OSS) form, more particularly due to its non-submission of an original and notarized OSS issued by the joint venture duly signed by its authorized representative.

**NOW, THEREFORE, WE**, the Members of the PMO-BAC, hereby **RESOLVE** as it is hereby **RESOLVED** to:

- To declare H. O. Noveloso Surveying Joint Venture with H.O. Noveloso and Associates as Post-Disqualified for the Procurement of Geodetic Services for the Conduct of Technical and Relocation Survey;
- b) To declare failure of bidding in accordance with Section 35.1 (c) of the Revised IRR of RA No. 9184; and
- c) Initiate the conduct of a mandatory review and evaluation of the terms, conditions, and specifications of the bidding documents for the Project.
